^v In cases where Members are required to conduct major maintenance and/or time consuming repairs which are expected to require in excess of 26 weeks, they may apply in writing to the Committee to remain at the \$150.00 per week rate. Such application should provide details of maintenance/repairs in progress, with an expected completion date for consideration by the Committee. All applications for exemption will be considered by the Committee. Its decision will be conveyed to the Applicant in writing by the Secretary.
